Explanation of Responses:

Each share of IAC Class B common stock is entitled to ten votes per share and each share of IAC common stock is entitled to one vote per share.
- Represents shares of IAC Class B common stock acquired from Barry Diller (Mr. Von Furstenberg's stepfather) by a trust for the benefit of certain family members of Mr. Diller in connection with the long-term estate planning of Mr. Diller and his family.
- In connection with the transfer referred to in footnote (2) above, the trust executed a promissory note payable to Mr. Diller in the aggregate amount of approximately \$24.3 million.
- Held by a family trust over which Mr. Von Furstenberg has investment power. Mr. Von Furstenberg disclaims beneficial ownership of such securities except to the extent of his pecuniary interest therein.
